With a performance of +10.2%\* YTD and a moderate volatility (4.2%), the fund ranks in the 1<sup>st</sup> decile (*Category Convertibles Europe Morningstar*) but also over longer periods (1, 3 and 5 years) and is rated 5\* stars by Morningstar.

Our unconventional investment approach, which is exclusively concentrated on convertible bonds and on all kind of profiles, is based on **Convertible bond-picking**. The fund gives access to the European convertible bond market (min. 70% Euro) with a limited number of positions (ca. 50) and a flexible average delta (55% max.). The investment objective of **QUILVEST CONVERTIBLES EUROPE** is to achieve long term capital growth by investing mainly in convertible bonds.

The fund is registered in **France** and **Switzerland.** Shares are available in <u>EURO</u> and <u>CHF</u> (I & P) with a daily valuation and a currency risk hedging.
