# What is this product?

#### TYPE OF PRODUCT

The product is a sub-fund of Dynasty SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

#### TERM

The Fund is established for an unlimited duration. However the Board of Directors of the Fund may decide to close the Fund under certain circumstances. OBJECTIVES

The objective of the Class A EUR shares of "Dynasty Corporate Bonds 0- 2.5" (the "Sub-Fund") is to provide positive returns over the short term, through the selection of a portfolio of fixed income asset classes, markets and fixed income financial instruments offering an attractive yield considering the issuer's credit risk.

The Sub-Fund has no benchmark and is actively managed. The Sub-Fund does not offer any form of guarantee with respect to investment performance and no form of capital protection applies.

The investment policy of the Sub-Fund consists in holding a portfolio of corporate fixed-income securities. Such securities will have, at the time of their acquisition, an attractive yield, taking into account the creditworthiness of their issuer. The maturity or early reimbursement dates (put and/or call) of the fixed-income securities held in portfolio will not exceed 10 years.

The Sub-Fund's average credit duration will range between 0 and 2.5 years and the Sub-Fund's average interest rate duration range from 0 to 2.5 years.

The fixed income securities are only denominated in euros (70% minimum) and mainly issued by European issuers (50% minimum). The balance, i.e. 30% maximum, can be denominated in hard currencies other than the euro (USD, GBP, CHF, etc.), and up to 50% can be invested in bonds issued by international issuers (i.e. non-European).

The selection of fixed income instruments will essentially depend on the analysis of their issuer's creditworthiness, based on a thorough analysis of their solvability.

Standard bonds as well as convertible bonds may have no minimum rating at the time of their acquisition. Exposure to High Yield or unrated bonds will therefore be possible up to 70% of the net assets of the SubFund and at least 30% of the net assets of the Sub-Fund will be invested in investment grade bonds.

Derivatives instruments may only be used in the context of hedging the Sub-Fund's assets against the interest rate, credit and FX risk. The commitment resulting from such transactions and contracts may not exceed the Sub-Fund's assets.

The income of the Class A EUR Shares is reinvested. The Class A EUR share is denominated in EUR.

The investor can obtain redemption of his shares on a simple demand transmitted by 4 p.m. two (2) Luxembourg business days before each valuation day to the register and transfer agent. Orders are executed on the basis of the NAV calculated on the relevant valuation day. Settlement will occur two business days after the relevant valuation day.

The return of the product is determined using the net asset value calculated by the Central administration. This return depends mainly on the market value fluctuations of the underlying investments.

The Sub-Fund's assets are seggregated from assets of other Sub-Funds of the Fund. The assets of the Sub-Fund cannot be used to pay debts of other sub-funds.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations

#### INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 2 years.

The risk indicator assumes you keep the product for 2 years.

The risk can be significantly different if you cash in at an early stage and you may get back less.
